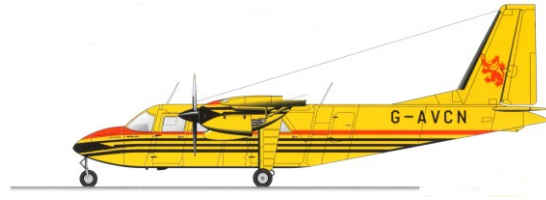


## BNAPS Supporters Club Details and Application Form

### Supporters Club Membership Donation Rates

All donations should be made to BNAPS and will be used by the charity in furtherance of its charitable aims.

Yearly suggested minimum membership donation rates/year are:

- Senior (over 60) £20.00
- Young adult (16 to 25) £12.00
- Corporate £100.00

*Renewal notices will be sent out at the end of March, end of June, end of September and the end of December dependent on the date of joining.*

*For example: if joining on 20 July, 2016, then the first renewal notice would be sent on 30 September, 2017, renewal notices from then would be sent out on 31 March.*
